E	2	✓	It is the contractor's responsibility to ensure minimal wastage of materials. TW reserves the right to levy charges against the contractor in the event of excess materials wastage.

Н Drainage or weep holes are to be formed beneath the slabs and re-drilled if necessary. Beams and stairs are to have lifting eyes. Any damage to blockwork caused by using chains around the beams or stairs will be charged to the Н contractor. If beams are too heavy to be lifted into place by either the contractor's mobile crane or Company tower crane (if previously negotiated) then subcontractor to allow for splitting beams or stairs. If the units have already been manufactured then the contractor is to allow them to be cut.
